The Florida Irrigation Society is sponsoring a two-day irrigation review course for the Certified Irrigation Contractor exam, and a separate day for Irrigation Association Certification Exams in Jacksonville and Daytona Beach. **The two-day irrigation review course is approved for 12 CEU's in Volusia County.**

Certified Irrigation Contractor Review Course: **Jacksonville – Tuesday, August 17, 2010 and Wednesday, August 18, 2010; 10:00 am – 4:00 pm both days. Daytona Beach – Tuesday, September 14, 2010 and Wednesday, September 15, 2010; 10:00 am – 4:00 pm both days** - Register with the Florida Irrigation Society. Certified Irrigation Contractor Course and Exam Location: **Jacksonville:** JEA Conservation Center, 950 N. Main Street, Jacksonville, FL 32202. **Daytona Beach:** Daytona Beach Public Works, 950 Bellevue Avenue, Daytona Beach 32114.

Irrigation Association Certification Exams: Will be held in Jacksonville on Thursday, August 19, 2010; 8:00 am – 12:30 pm – Register with Irrigation Association online by July 21, 2010, and in Daytona Beach on Thursday, September 16, 2010; 8:00 am – 12:30 pm – Register with Irrigation Association online by August 18, 2010. You must be prequalified with one year irrigation related experience and three years irrigation related field experience. **Important, you must have registered and submitted your payment to the Irrigation Association at least 30 days in advance in order to sit for the exam.**

You are not required to take the exam immediately after this class. In fact you may take the exam at any time, at any IA exam location at your convenience. It is recommended that you order the CIC manual from the IA in advance for extensive self study. You should study the manual first, identify the areas you do not understand and be prepared to focus on these areas in class. Conversely you may take the class first, self study the manual focusing on the areas in which you need to review.

### **Step 1 – Applying to the Program and Registering for the Exam**

To apply to the program and register for the exam, fill out the Certified Irrigation Contractor Program Application & Registration and **submit it to the Irrigation Association** with payment. There is a minimum requirement of at least one (1) year work experience in an irrigation-related field with a total of at least three (3) years of irrigation-related field experience. **Your application/registration must be submitted at least 30 days in advance of the exam with payment.**

After your application has been received and verified by the Irrigation Association, you will receive a letter informing you of your status in the program and confirmation of the exam date and location

**IMPORTANT INFORMATION: YOU ARE NOT REGISTERED TO TAKE THE EXAM UNTIL YOU RECEIVE A CONFIRMATION FROM THE IRRIGATION ASSOCIATION.**

### **Step 2 – Take and Pass the Examination**

In order to become certified, you must take and pass the Certified Irrigation Contractor examination. The examination is a 4-hour, closed book exam consisting of 180 equally-weighted, multiple choice questions. The content and approximate percentages for each area can be found in the Certified Irrigation Contractor Application/Registration Form. You may take the exam at any time, not just at the exam date in conjunction with a particular class. The Irrigation Association Website ([www.irrigation.org](http://www.irrigation.org)) will post exam dates and sites. All Irrigation Association exams are given at all exams sites and dates.

## **TWO DAY CERTIFIED IRRIGATION CONTRACTOR TRAINING COURSE**

The Florida Irrigation Society is sponsoring a two-day review course entitled Certified Irrigation Contractor Training on August 17, 2010 and August 18, 2010 at the JEA Conservation Center, Jacksonville, and in September 14, 2010 and September, 15, 2010 at Daytona Beach Public Works, Daytona Beach. This Course serves two functions:

1. To help professionals in the irrigation industry understand what is expected of a competent irrigation contractor and to identify areas and topics in which they should be proficient, so as to be profitable and professional.
2. To refresh the existing skills of irrigation contractors.

During the two-day class, students will review advanced soil-water-plant relationships, advanced hydraulics and design principles, pumps, job safety requirements, national plumbing and electrical codes that affect our industry, basic business skills for a contractor, scheduling, water conservation, and details about system uniformity and efficiency. Completion of the 2-day training seminar does not guarantee the participant will pass the Irrigation Association's CIC exam.

An Introduction to Florida Water Star irrigation standards will be included. This section will focus on water conserving irrigation techniques and requirements for Florida Water Star Gold and Bronze level certifications for residential properties. This important criteria has been adopted as code by several local municipalities for new designs and renovation of existing irrigation systems and portions may be utilized in future regulations.

## EXAM PREPARATION RECOMMENDATIONS

In order to pass the certification exam, you should expect to spend at least 30 to 60 hours of self-study. There are two recommended tracks of preparation for the exam:

### Preparation Track A

1. Apply for the program and register for the exam through the Irrigation Association (at least 30 days prior to the desired exam date).
  - a. Order the ***Irrigation Contractor Workbook*** from the Irrigation Association (can be ordered with the Application or purchased separately) or other recommended exam references.
2. Study for 30 to 60 hours (30 days) on your own.
3. Define the material with which you need help.
4. Take the 2 day Certified Irrigation Contractor Training Course to become proficient in your weak areas of knowledge.
5. Take the exam in conjunction with the class.

### Preparation Track B

1. Apply for the program through the Irrigation Association (you can also register for a future exam date.)
  - a. Order the ***Irrigation Contractor Workbook*** from the Irrigation Association (can be ordered with the Application or purchased separately) or other recommended exam references.
2. Review the book to define material with which you need help.
3. Take the 2 day Certified Irrigation Contractor Training Course to review the material on which you need to concentrate your studying.
4. Study for 30 to 60 hours (minimum of 30 days) on your own.
5. Take the exam. (Be sure to sign up at least 30 days prior to your desired exam date.)
